Approved by the Centre Board on 2nd February 2024.

The academic year begins on **1st September 2024** and ends on **31st August 2025**.

REGISTRATION

The instructions for completing registration are included in the online registration documents which can be found on the UPV home page (www.upv.es). The registration deadline is as follows:

- **Newly registered students admitted in preregistration.**
 - Registration orientation talk: 15th July 2024 at 09:30 online.
 - Registration: 16th and 17th July 2024.
- **Students in their second year or following years.**
 - Registration from 18th to 22nd July 2024, inclusive.
- **Students admitted with partially completed studies at Spanish universities, or with studies at foreign universities.**
 - Registration: 29th July 2024.
- **Students who request an exemption from the permanence regulations and obtain enrolment authorization.**
 - Registration: From 29th July 2024.

Registration cancellation

The cancellation of the registration implies the total or partial cancellation of subjects of the course and implies the reimbursement to the student of the amount paid up to that date corresponding to public prices for teaching activities. After the general deadline, registration cancellation requests may be accepted, and the economic effects will be indicated by their resolution.

- Deadline: 31st October 2024.

CLASS PLANNING

Semester A

Welcome Days will be on 5th and 6th September 2024, which must be attended by all new students.

Classes shall begin on 9th September 2024 and finish on 31st January 2025.

In this semester there are two teaching changes:

- On Tuesday 8th October 2024 students will be taught lessons planned for Wednesdays.
- On Thursday 5th December 2024 students will be taught lessons planned for Fridays.

The first, second and third year students of the MAT+GIINF double degree will follow the academic calendar of the ETS of Telecommunications Engineering.

The first and second year students of the double degree of IOI+CD will follow the academic calendar of the ETSII, since the teaching is given in said school this semester.

Semester B

Classes shall begin on 3rd February 2025 and finish on 2nd July 2025.

For the 4th year students, the semester will begin on 3rd February 2025 and finish on 8th May 2025.

In this semester there are two teaching changes:

- On Wednesday 16th April 2025 students will be taught lessons planned for Fridays.
- On Tuesday 29th April 2025 students will be taught lessons planned for Thursdays.

The student of the double degree of ADE+GIINF will be governed by the academic calendar of the ADE faculty, since this semester is taught in said faculty.

The first-year students of the MAT+GIINF double degree will follow the academic calendar of the ETS of Telecommunications Engineering.

PLANNING OF EVALUATION EVENTS

To facilitate planning different pieces of assessment and compliance with UPV's Academic Regulations and Student Assessment policies, the centre reserves specific days for them to be carried out for certain courses as requested.

In semester A, assessment events will be held from 30th October to 6th November 2024. In addition, after the end of the semester classes, the days from 7th to 31th January 2025 will be reserved.

Similarly, in semester B (except 4th year), the days from 2nd to 8th April 2025 are reserved for evaluation. In addition, after the end of classes, the days from 2nd June to 2nd July 2025 are also reserved.

In the specific case of the optional subjects in Semester B of the 4th year, the days following the end of classes are reserved for assessment events, from 2nd to 8th May 2025.

DEADLINE FOR PRESENTING RECORDS

The deadline for handing in records shall be 21st February 2025 by 12:00 noon for semester A and 14th July 2025 by 12:00 noon for semester B and annual.

For courses in fourth year, semester B, the deadline shall be Friday 26th May 2024 by 12:00 noon.

These deadlines cannot be extended.

ASSESSMENT BY ACADEMIC CURRICULUM

Assessment by academic curriculum shall be carried out when the final grade for all courses in the academic year is given and adjusted to the following schedule:

- Assessment and presentation of proposals by ERT (Body in Charge of Degrees): from 15th to 16th July 2025 inclusive.
- CPEC (Standing Committee for Curriculum Assessment) Resolution: Until 21st July 2025.

These dates for the assessment of blocks made up of courses from semester B in fourth year of bachelor's degrees may be planned in May. These shall count as definite grades which aims to allow students to finish their studies.

END OF DEGREE PROJECT (EDP)

Registration and Cancellation

Registration shall be carried out within the period established for this purpose in the academic calendar of each course, on the date assigned in the self-registration. Registration may be cancelled before 31st May 2025, provided that the defense of the work has not been initiated.

Allocation of EDP

EDP's shall be allocated at the beginning of the academic year. For the agreed external projects, allocation shall be done throughout the academic year. In any case, please consider that there must be a 10-week gap between being allocated a project and requesting an appointment to defend the project.
